## Grade 7 Mathematics Paper-Based Practice Test Answer Key

The rubrics also show sample student responses; other valid methods for solving the problem can earn full credit unless a specific method is required by the item. In items where the scores are awarded for full and partial credit, students can still earn points for reasoning or modeling even if they make a computation error.

| $\mathbf{4}$ | The student response demonstrates an exemplary understanding of the Ratios and <br> Proportional Relationships concepts involved in using proportional <br> relationships to solve multi-step ratio and percent problems. The student uses proportional <br> relationships in three different situations to solve for either distance, time, or rate. |
| $\mathbf{3}$ | The student response demonstrates a good understanding of the Ratios and <br> Proportional Relationships concepts involved in using proportional relationships to solve <br> multi-step ratio and percent problems. Although there is significant evidence that the student <br> was able to recognize and apply the concepts involved, some aspect of the response is <br> flawed. As a result the response merits 3 points. |
| $\mathbf{2}$ | The student response demonstrates a fair understanding of the Ratios and <br> Proportional Relationships concepts involved in using proportional <br> relationships to solve multi-step ratio and percent problems. While some <br> aspects of the task are completed correctly, others are not. The mixed evidence provided by <br> the student merits 2 points. |
| $\mathbf{0}$ | The student response demonstrates a minimal understanding of the Ratios and <br> Proportional Relationships concepts involved in using proportional <br> relationships to solve multi-step ratio and percent problems. |
|  | The student response contains insufficient evidence of an understanding of the Ratios and <br> Proportional Relationships concepts involved in using proportional <br> relationships to solve multi-step ratio and percent problems to merit any points. |
